CCA Funds

- Legislature is responsible for appropriating and determining which activities and projects are funded
- CCA requires that a minimum of 35%, with a goal of 40%, of auctiongenerated revenue be used for projects that provide a direct benefit to vulnerable populations within overburdened communities
- 10% of auction funds must be used for projects with Tribal support

Carbon Emissions Reduction Account (CERA)

- FY2023, funds appropriated to WSDOT and TIB were used to fund six grant programs with over 100 projects funded for a total expenditure of \$52,245,587.
- Funded projects included fleet transition plans, feasibility studies, operating and capital equipment projects.



Carbon Emissions Reduction Account (CERA)

- Examples of programs funded in 2023-25 biennium:
 - \$403M for public transit grants and projects
 - \$157M for active transportation projects, e.g. bike trails & safer sidewalks
 - \$120M for incentives and infrastructure to support zero-emission commercial vehicles, including school buses and drayage trucks

Climate Investment Account

- Examples of programs funded in 2023-25 biennium:
 - \$60M in riparian protection grants
 - \$30M for fish passage projects
 - \$11M for the Conservation Reserve Enhancement program



Air Quality & Health Disparities Improvement Account

- 16 locations across Washington identified as meeting this definition
 - mix of urban, suburban, and rural communities totaling
 1.2M people
- Examples of programs funded in 2023-25 biennium:
 - \$25M to improve air quality in overburdened communities
 - \$26M for grants to Tribes and overburdened communities related to implementing the HEAL Act and updating the Department of Health's environmental health disparities map




Air Quality & Health Disparities Improvement Account

Auction Results

- Auction #1: Feb. 28, 2023
 - Settlement price \$48.50 in line with economic analysis
 - All 6.2M allowances sold, competitive auction
 - Total revenue just under \$300M, subject to appropriation
- Auction #2: May 31, 2023
 - Settlement price \$56.01 (2023), \$31.12 (2026)
 - All 8.6M (2023) and 2.45M (2026) allowances sold
 - Total revenue about \$550M, subject to appropriation
 - APCR Auction #1 triggered, scheduled for Aug. 9





Auction Results

- APCR Auction #1: Aug. 9, 2023
 - Allowances sold at two pre-set 'Tiers': \$51.90 and \$66.68, set in rule
 - All 1,054,000 vintage-less allowances sold, 527,000 in each tier
 - Total revenue just over \$62M, subject to appropriation
- Auction #3: Aug. 30, 2023
 - Settlement price \$63.03 (2023)
 - All 8.6M (2023) sold; 5.7M state-owned, 2.9M consigned by utilities
 - Total revenue just over \$356M to state, subject to appropriation, plus \$184M to utilities for benefit of ratepayers
 - APCR Auction #2 triggered, scheduled for Nov. 8



Auction Results

- APCR Auction #2: Nov. 8, 2023
 - Only Tier 1 allowances were sold
 - Allowances sold at pre-set price: \$51.90, set in rule
 - Sold 5,000,000 allowances
 - Total revenue \$253M, subject to appropriation
- Auction #4: Dec. 6, 2023
 - Allowances being auctioned
 - Current Vintage 7,142,146
 - 2026 Vintage 2,449,760



- Operating \$444.8 mill
- Capital \$717.2 mill
- Transportation \$967.7 mill
