Workgroup Purpose

Purpose: Divert organic material and improve the organic material management system in Washington is order to reduce methane and combat climate change and provide certainty for future action.

2024 Workgroups Focus:

- Build on the work of 2021 and 2023 Organics Workgroups that helped provide stakeholder input for HB1799 and HB2301
- Address specific topics that can lead to increased organics diversion, clean compost, and recovery of edible food
- Provide forum for stakeholders to give comment and suggest edits to 2025 bill language, for negotiation meetings on each topic
